INC. (ONLY)**


IT IS ORDERED AND ADJUDGED:

That Judgment is hereby entered in accordance with the Court's Order on January 17, 2017, granting summary judgment in favor of Defendant Kelly Services on all claims plead by Plaintiff.

The court finds pursuant to FRCP 54(b) that entry of judgment is warranted in favor of Kelly Services, Inc. ("KSI"), and there is no just reason to delay entry where (1) the grounds for complete summary judgment in favor of KSI are independent of the issues concerning the remaining defendants, and (2) the equities and efficient judicial administration favor entry of judgment, with the case now moving to issues of class certification and potential class liability (matters in which KSI is not a participant).
